#### 1. Call to Order and Roll Call:

The regular monthly meeting of the Metropolitan Sewerage District Board was held in the Boardroom of MSD's Administration Building at 2:00 pm, Wednesday, November 15, 2023. Chairman VeHaun presided with the following members present: Bryson, Dearth, Franklin, Kelly, Lapsley, Manheimer, Pelly, Pennington, Watts, Whitesides and Wisler. Ashley and Moore were absent.

Others present were William Clarke, General Counsel; Patty Beaver with CIBO; Brian Goldstein with Woodfin Sanitary Water & Sewer District; Tom Hartye, Hunter Carson, Mike Stamey, Bart Farmer, Angel Banks, Scott Powell, Pam Thomas, Ken Stines, Spencer Nay and Pam Nolan, MSD.

#### 2. Inquiry as to Conflict of Interest:

Mr. VeHaun asked if there were any conflicts of interest with the agenda items. No conflicts were reported.

#### 3. Approval of Minutes of the October 18, 2023 Board Meeting:

Mr. VeHaun asked if there were any changes to the Minutes of the October 18, 2023 Board Meeting. Mr. Watts moved for approval of the minutes as presented. Ms. Bryson seconded the motion. Voice vote in favor of the motion was unanimous.

#### 5. Introduction of Guests:

Mr. VeHaun welcomed Patty Beaver with CIBO and Brian Goldstein from Woodfin Sanitary Water & Sewer District.

#### 7. Report of General Manager:

Mr. Hartye reported that attached there was a link to the FY 2023 Audit and Annual Comprehensive Financial Report. The District's Auditor will give a presentation of the FY 2023 Audit at the January 17<sup>th</sup> Board Meeting.

Mr. Hartye reported that attached is a letter of appreciation from James and Brenda Wildt of Woodland Ridge in Asheville regarding the great response and attitudes of MSD's System Services Personnel. Thanks to Mitch Metcalf, Dylan Dyer, Mitch Hawes, Chase Jones, Grey Clough, Nicolas Hercules, and Dalton Hyatt.

Mr. Hartye reported that attached is a thank you note from the Junior League of Asheville for MSD's role in the "Touch-A-Truck" 2023. Thanks to Grey Clough and Chase Jones.

Mr. Hartye reported that the next regular Board Meeting will be held on January 17, 2024 at 2 pm. The November Right of Way Committee meeting is cancelled. The next Right of Way Committee meeting will be held on January 24, 2024 at 9 am.

#### 8. Consolidated Motion Agenda:

#### a. Consideration of Bids - Buchanan Avenue GSR:

Mr. Hartye reported that this project is located in downtown Asheville near Biltmore Avenue and is comprised of 2,204 LF of 8-inch ductile iron pipe. The existing line is 6-inch clay with heavy root intrusion, fractures and one section of exposed pipe along a steep grade. The project was advertised formally on October 12, 2023 at 2 pm and three sealed bids were received as follows: Huntley Construction Company with a bid amount of \$1,293,771.00; T.P. Howard's Plumbing Co., Inc. with a bid amount of \$1,200,000.00; and Terry Brothers Construction Company with a bid amount of \$876,159.40. The apparent low bidder is Terry Brothers Construction Company with a bid amount of \$876,159.40. Terry Brothers has done much work for the District and their work is very good. The FY 23-24 construction budget for this project is \$1,277,000. Staff recommends award of this contract to Terry Brothers Construction Company, contingent upon review and approval by District Counsel. Mr. Lapsley stated that there was a pretty big difference between the low bidder and the second bid, and is everybody comfortable with that? Mr. Hartye said yes. He further stated that 2,200 LF is about \$400 per foot and wanted everybody to realize how much sewer costs and this is only an 8-inch pipe. There was some discussion regarding the increase in pipe cost over the years. Mr. Lapsley stated that he was trying to make a point that if he was the low bidder and saw that he was that far apart from the other bidders, he would be nervous that he had mispriced something and be concerned with the bonding company. Mr. Hartye stated that the District would be if this were someone from out of town that the District had not worked with already. This company gets most of our projects and are more familiar with District work than anyone.

#### b. MSD Mull Building HVAC Renovations Phase 3 – Information Only:

Mr. Hartye reported that this project is located inside the District's Mull Building. This is the third phase of the HVAC project and includes replacement of two boilers and hot water pumps, as well as integration of the hot water system into the Building Automation System (BAS) controls interface. The contract was advertised and two sealed bids were received on November 2, 2023 at 2pm as follows: MSS Solutions, LLC with a bid amount of \$282,767.00; and Bolton Construction with a bid amount of \$190,154.00. Bolton Construction is the apparent low bidder with a bid amount of \$190,154.00. They were awarded Phase II of this project, have extensive experience, and do good work. The FY 23-24 construction budget for this project is \$218,000.00. Staff recommends award of this contract to Bolton Construction, contingent upon review and approval by District Counsel.

#### c. Sand Hill Odor Control - Information Only:

Mr. Hartye reported that this project is located on Sand Hill Road in West Asheville along Hominy Creek. It is on MSD owned property and includes the

construction of a new odor control dosing station. The station utilizes Bioxide (calcium nitrate), a chemical that controls hydrogen sulfide odors, reduces corrosion, and provides a safer working environment throughout the sewer collection system. The project includes the installation of a raised platform to support a chemical dosing tank, new chemical pumps, SCADA cabinetry, new electric and water services, and chemical discharge line to an existing sewer manhole. This project will replace the previous odor control station that was washed away by Tropical Storm Fred in 2021. The contract was advertised, and four bids were received on November 2, 2023 at 2:30 pm as follows: Haynes Electric Utility with a bid amount of \$191,619.00; TP Howard's Plumbing Co. with a bid amount of \$125,210.00; Cove Utility, LLC with a bid amount of \$113,000.00; and Keys Construction with a bid amount of \$86,100.00. The apparent low bidder is Keys Construction with a bid amount of \$86,100.00. Keys Construction is experienced in this type of work. The FY 23-24 construction budget for this project is \$75,000.00. Sufficient funds are available in the CIP contingency for the overage. Staff recommends award of this contract to Keys Construction, contingent upon review and approval by District Counsel.

#### d. Consideration of Bids – RBC Removal – Information Only:

Mr. Hartye reported that this project is located at the treatment plant and includes removal and disposal of non-functional rotating biological contactors (RBCs). MSD originally installed 152 RBCs in 1988. Currently 13 RBCs are broken and in need of removal. Informal bids were solicited from multiple salvage/demolition contractors and only one was responsive. On November 3, 2023 a proposal was received from D.H. Griffin Wrecking Co. Inc. in the amount of \$348,000.00. D.H. Griffin has performed demolition services for the District successfully in the past. The FY 23-24 construction budget for this project is \$458,241.00. Staff recommends award of this contract to D.H. Griffin Wrecking Company, Inc., contingent upon review and approval by District Counsel.

### e. Consideration of Developer Constructed Sewer Systems – 12 Fishers Mill; CMH Avery Creek; Olivette Phase 2D; Suncap Warehouse:

Mr. Hartye reported that the 12 Fisher's Mill project is located in Buncombe County and included extending approximately 378 linear feet of 8-inch public gravity sewer to serve 3 residential units.

Mr. Hartye reported that the CMH Avery Creek project is located along Avery Creek Road in Buncombe County and included extending approximately 578 linear feet of 8-inch public gravity sewer to serve 10 residential units.

Mr. Hartye reported that the Olivette Phase 2D project is located off Olivette Crossing Parkway in the Town of Woodfin and included extending approximately 1.032 linear feet of 8-inch public gravity sewer to serve 13 homes in this phase of the residential development.

Mr. Hartye reported that the Suncap Warehouse project is located at the end of Ferncliff Park Drive in Henderson County and included extending approximately 1,500 linear feet of 8-inch public gravity sewer to serve a warehouse and distribution facility.

Staff recommends acceptance of the aforementioned developer constructed sewer system. All MSD requirements have been met.

#### f. First Quarter Budget to Actual Review FY 24:

Mr. Powell reported that Page 34 presents the District's First Quarter Budget to Actual Review and Expenditure Report. Domestic User Fees and Industrial User Fees are at budgeted expectations. Facility Fees and Tap Fees are above budgeted expectations due to development. Interest and miscellaneous income are above budgeted expectations due to short-term interest rates being higher than anticipated for the fiscal year. O&M expenditures are at 28.46% of budget. They include encumbered amounts which has elevated the budget to actual above 25%. Bond principal and interest expenditures are at 80%. This is due to the principal and interest expenditures on July 1. Amounts budgeted for capital equipment and capital projects are rarely expended proportionately throughout the year.

#### g. Cash Commitment/Investment Report – Month ended September, 2023:

Mr. Powell reported that Page 38 presents the District's Investment Portfolio. There has been no change in the makeup of the portfolio from the prior month. Page 39 presents the Investment Manager's Report as of the month of September. The weighted average maturity of the investment portfolio is 94 days. The yield to maturity is 5.23%. Page 42 presents the MSD Variable Debt Service Report. The 2008 Series Bonds are performing at budgeted expectations. As of the end of October, this issue has saved the District rate payers over \$7.5 million in debt service.

With no further discussion, Mr. VeHaun called for a motion to approve the Consolidated Motion Agenda. Mr. Pelly moved, Ms. Wisler seconded the motion. Roll call vote was as follows: 12 ayes; 0 nays.

#### 10. New Business:

Mr. Hartye reminded everyone that Status Reports for all construction projects are included at the end of the Board Agenda package and encourages everyone to look at these.

#### BOARD OF THE METROPOLITAN SEWERAGE DISTRICT October 18, 2023

#### 1. Call to Order and Roll Call:

The regular monthly meeting of the Metropolitan Sewerage District Board was held in the Boardroom of MSD's Administration Building at 2:00 pm, Wednesday, October 18, 2023. Chairman VeHaun presided with the following members present: Bryson, Dearth, Kelly, Lapsley, Manheimer, Pelly, Pennington, Watts, and Wisler. Ashley, Franklin, Moore and Whitesides were absent.

Others present were William Clarke, General Counsel; Forrest Westall, PE, with McGill Associates; Patty Beaver with CIBO; Brian Goldstein with Woodfin Sanitary Water & Sewer District; Tom Hartye, Hunter Carson, Mike Stamey, Pam Thomas, Heather Young, Angel Banks, Kevin Johnson, Spencer Nay and Pam Nolan, MSD.

#### 2. Inquiry as to Conflict of Interest:

Mr. VeHaun asked if there were any conflicts of interest with the agenda items. No conflicts were reported.

#### 3. Approval of Minutes of the September 20, 2023 Board Meeting:

Mr. VeHaun asked if there were any changes to the Minutes of the September 20, 2023 Board Meeting. Mr. Kelly moved for approval of the minutes as presented. Mr. Pelly seconded the motion. Voice vote in favor of the motion was unanimous.

#### 4. Discussion and Adjustment of Agenda:

None.

#### 5. Introduction of Guests:

Mr. VeHaun welcomed Patty Beaver with CIBO and Brian Goldstein from Woodfin Sanitary Water & Sewer District.

#### 6. Informal Discussion and Public Comment:

None.

#### 7. Report of General Manager:

Mr. Hartye congratulated "Employees of the Year" Patrick Smith for the Treatment Plant, Rick Bradley for System Services and Angela Lewis for Admin/Engineering.

Mr. Hartye reported that attached is an excerpt of MSD's Sewer Extension Policy that outlines MSD's participation programs for extension of sewers. These reimbursement programs have been discussed at Planning Committee and other times. MSD will only reimburse in areas inside the District Boundary or serving areas within Primary Areas as identified in the District's Master Plan. There are six types of reimbursements. The first being Rehabilitation of Existing Sewer Lines and Pump Stations. If an extension will connect to an existing sewer line which is Undersized and will require improvements with a larger diameter pipe to provide

adequate capacity, or will connect through an existing pump station, the District will require developer to upgrade that line as far as is necessary for the system to be viable. MSD will participate in that upgrade. There is a scoring system used to participate in that upgrade that factors in the age of the system, whether it's on the Master Plan to be upgraded and that type of thing. (2) Additional Capacity Reimbursement is for the extension itself. An example would be if MSD requires a 12-inch line and the developer only needs an 8-inch line to get to their development, MSD will pay the difference in the 8-inch and 12-inch line. If the line is 12-inches or larger, the District will provide design and right of way acquisition services. This is only considered if the extension will serve individual properties and customers outside of developer's project and allow for future orderly development. (3) Documented Failing Septic Tank Emergencies is what is on the Agenda today. This is ten years of estimated revenue and is up front as soon as the extension is complete and approved by MSD. There are certain factors that have to be addressed. It must be in an area identified for public sewer, there must be a public health hazard, and there must be a letter from Local Government and the Buncombe County Health Department stating on site repair is not possible. MSD will prepare preliminary design and project cost estimates for agreement to be entered into by parties involved, and MSD will also provide right of way acquisition services and administer construction. (4) New Affordable Housing Projects. These are eligible for the equivalent of five years of estimated revenues up to \$50,000 if the development meets the Affordable Housing criteria of the local governing jurisdiction. (5) Revenue Sharing for Extensions made by Others. If an extension is run from an MSD line to development, MSD will reimburse 50% of actual user charge revenues MSD receives from that line for 10 years to be disbursed semi-annually by MSD. (6) Developer to Developer Reimbursements. If a second developer ties onto an extension run by the first developer, MSD will collect a proportionate share from the new developer to give to the first developer. This way the original developer can be assured that, for 10 years, MSD will go back and collect a proportionate share from the second developer. Most policies are for new developments and the Board has seen several throughout the years. On the agenda today is for Documented Failing Septic Tank Emergencies and is the first one MSD has had.

Mr. Hartye reported that the next Board Meeting will be held on November 15<sup>th</sup> at 2 pm.

#### 8. Report of Committees:

#### a. Right of Way Committee – September 27, 2023:

Mr. Kelly reported that the Right of Way Committee met on September 27, 2023 and made routine recommendations which are noted in the Consolidated Motion Agenda. There were no questions.

#### 9. Consolidated Motion Agenda:

### a. Consideration of Bids – Intermediate Clarifier Trough Rehabilitation Phase 1:

Mr. Hartye reported that the intermediate clarifier was placed into operation in 1990. What now needs replacing are weir troughs. These troughs collect clarified water to transfer to the next process. They are in poor condition and are leaking due to significant corrosion. After trying to rehabilitate these troughs, MSD Staff

determined that the scope of the project should change to a full trough replacement. Fiberglass reinforced polymer (FRP) troughs were chosen for superior corrosion resistance and equivalent strength when compared to aluminum troughs at a comparable price point. This project has been divided into 2 phases. Phase 1 is scheduled for completion in Spring, 2024. Phase 1 was advertised formally and two bids were received on September 22, 2023. Therefore, the project was re-advertised and two bids were received on October 2, 2023 as follows: Cove Utility, LLC with a base bid of \$534,000; and Harper General Contractors, Inc. with base bid of \$577,900. The apparent low bidder is Cove Utility, LLC with a base bid amount of \$534,000. The FY 23-24 construction budget for this project is \$850,000.00. Staff recommends award of the base bid contract to Cove Utility LLC, in the amount of \$534,000, contingent upon review and approval by District Counsel.

### b. Contract for Easement Services – Weaverville Pump Station and Force Main Improvements:

Mr. Hartye reported that this project will replace Weaverville Pump Stations 1 and 2. The design includes entire replacement of Pump Station 1 and replacement of existing 12-inch and 18-inch force main with a 24-inch force main designed to pump directly to the treatment plant. Pump Station 2 will be converted to a small residential pump station. Requests for Proposals to acquire easements were sent to three easement acquisition companies and MSD received responses from two, Telics and Utility Land Services. Telics was chosen as the best fit for MSD's needs. Telics price is for \$3,500 per parcel, not to exceed \$105,000 for an estimated 30 parcels. Telics has done good work for MSD. Typically, right of way is acquired before construction is even started on a project. Due to the lead time for materials, pump instrumentation, and shop drawings, there will be a sixmonth administrative period between the bidding process and start of construction. Easement acquisition will begin during this administration period and continue while construction begins on the pump station site. Acquisition is expected to take one year. This item is for information only. Mr. Lapsley asked if the \$3,500 per parcel also includes land surveying to prepare the documents or if that cost was in addition to the \$3,500. Ms. Banks stated it does not, it only includes Telics' staff time and negotiations. Mr. Hartye stated that over the years, the total project cost and land acquisition has been less than 5%, usually around 3% so in the total scheme of things it's not a big number. Mr. Lapsley stated that MSD may have more money into negotiation services plus surveys than in the cost of actually acquiring the easement from the landowner. There was no further discussion.

### c. Consideration of Compensation Budget – Weaverville Pump Station and Force Main Improvements:

Mr. Hartye reported that this item is for the same project discussed above. Right of Way Committee recommends approval of this compensation budget.

### d. Consideration of Revenue Sharing – MSD Failing Septic Tank Emergencies Policy:

Dolce Lomita, LLC owns 6 existing mobile homes located at 15 and 17 Gatewood Road, adjacent to Emma Road in Asheville. The mobile homes are served by a shared septic system that is failing due to unsuitable soil conditions. Dulce Lomita, LLC was denied a permit by Buncombe County Health and

Human Services (BCHHS) to improve or repair the septic system due to insufficient space on site and has applied for MSD's Failing Septic Tank Emergencies reimbursement program. MSD participates by pledging 10 years of estimated revenues generated by user fees once the extension is complete and accepted by the MSD Board. The Policy also requires MSD to provide design and right of way acquisition services and to administer the construction of the extension. To begin this process, a letter from BCHHS is required stating that the onsite repair of the failed system is not possible. Also required is an Agreement signed by both parties, which is attached to the agenda item. The letter from BCHHS has been received. The 8-inch extension will be approximately 800 LF and will follow MSD's master plan alignment. Most of the extension lies within the NCDOT right of way; however, one easement on the lower portion is on private property and will require one easement. Estimated generated revenue is \$18,936. Reimbursement will not occur until the extension is complete, which is probably in next year's budget. Staff recommends that the District enter into a revenue sharing agreement with Dulce Lomita, LLC in the amount of \$18,936, subject to review and approval by District Counsel. Mr. Pennington asked if, theoretically, this line could be extended farther up the road for other failing septics? Mr. Hartye stated that is correct.

### e. Consideration of Developer Constructed Sewer Systems – Fountain Park Phase 2; Schwann's; Wolf Tract Cottages:

Mr. Hartye reported that the Fountain Park Phase 2 project is located off Pond Road in Buncombe County and included extending approximately 4,590 linear feet of 8-inch public gravity sewer to serve 120 residential units.

Mr. Hartye reported that the Schwann's project is located at Sand Hill Road and Jacob Holm Way in Buncombe County and included extending approximately 145 linear feet of 8-inch public gravity sewer to the commercial development.

Mr. Hartye reported that the Wolf Tract Cottages project is located at Skyland Circle and Brown Avenue in the Town of Woodfin and included extending approximately 183 linear feet of 8-inch public gravity sewer to serve 6 cottages in the residential development.

Staff recommends acceptance of the aforementioned developer constructed sewer system. All MSD requirements have been met.

#### f. Consideration of Procurement of (3) New Compact Utility Vehicles:

Mr. Hartye reported that at the March 13, 2023, Equipment Replacement Committee meeting, the members recommended the purchase of three (3) new 2023 compact utility vehicles. Formal bids were solicited, and Friendship Ford was the lowest, responsive, responsible bidder. Cost per vehicle is \$34,875 with the total cost for the 3 vehicles being \$104,625. Staff recommends the bid from Friendship Ford of Bristol, Tennessee be awarded subject to review and approval by District Counsel.

#### g. Cash Commitment/Investment Report - Month ended August, 2023:

Mr. Hartye reported that Page 43 presents the average rate of return which is 4.127%. Total Cash and Investments is \$82,699,724. If you take away all current obligations for insurance funds, current years budget, etc., it leaves \$23,034,825, which is designated for Capital Outlay. Page 45 is a breakdown of the District's Investment Portfolio. Page 46 is the Investment Manager's Report. Pages 47 and 48 present the YTD Expenses and Cash Receipts, both of which are at budgeted expectations. Page 49 presents the 2008A Series Synthetic Fixed Bond with

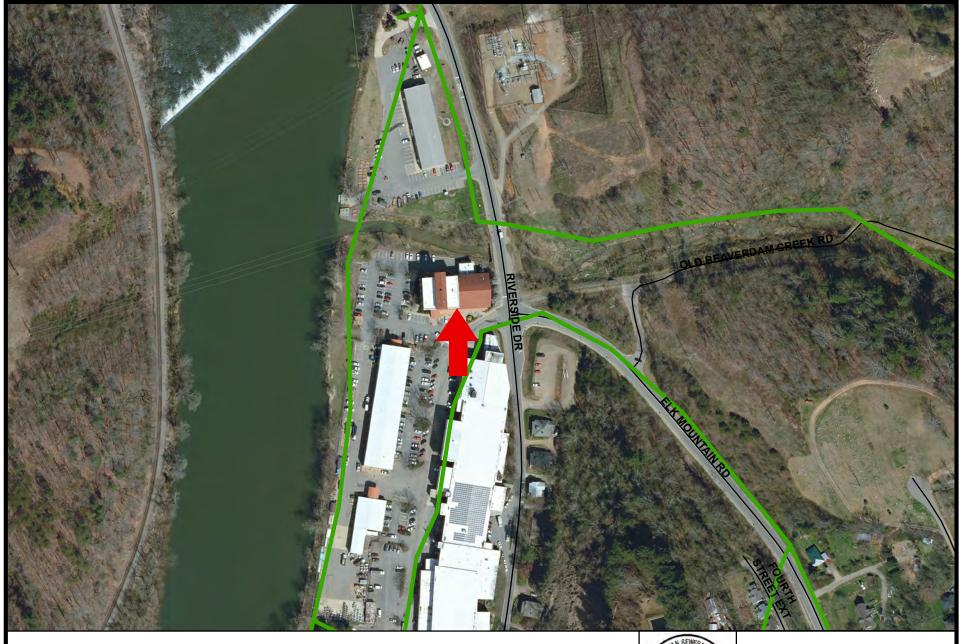

RBCs are large, cylindershaped treatment units made up of multiple plastic discs mounted on a horizontal steal shaft. The RBC units rotate through the wastewater where microorganisms colonize the plastic discs and form a thick, heavy biofilm. Over the past several years, some of the RBC units (originally installed in 1988) have failed due to excessive weight and broken shafts. When this occurs, the units provide no biological treatment and create a damming effect in the RBC basin, negatively impacting operation. Currently, thirteen

(13) RBCs are broken and in need of removal.

#### **Background**

At the end of each quarter, actual revenue and expenditure amounts are compared with the budget to evaluate performance. This information is based on cash revenues and invoices received prior to September 30, 2023 and may not include some accruals of revenue and expenditures.

## **Discussion**

There are several explanatory notes at the bottom of the attached Budget to Actual schedule.

Other considerations are as follows:

- Domestic and Industrial Revenue are at budget expectations. Staff Monitors consumption trends as they have a direct effect on the District's current revenue projections.
- Facility and Tap Fees are budgeted conservatively. The better than expected variance as of the end of the first quarter is due to receiving revenue from various development.
- Interest and miscellaneous income are above budgeted expectations. Actual short-term interest rates are higher than anticipated for the fiscal year.
- Rental income reflects are at budgeted expectations.

#### Discussion (continued)

- ◆ 0&M expenditures are at 28% of budget. The expenditures include encumbered amounts, which has elevated the budget to actual ratio above 25%. The aforementioned encumbrances will be spent in future quarters.
- ♣ Bond principal and interest are at 80%. This reflects principal and semi-annual interest payments on July 1, 2023.
- ♣ Amounts budgeted for capital equipment and capital projects are rarely expended proportionately throughout the year and are expected to be fully spent prior to the end of the year.
