Bids for the construction of the Project will be received at the MSD Training Center located at 2229 Riverside Drive, Asheville, North Carolina 28804, until Wednesday, June 18th at 2:00 PM local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

- Demolition of the existing pump station and site work.
- Construction of a new raw sewage pump station with mechanical screens and odor control.
- Construction of 60-inch influent gravity sewer via open cut and tunneling.
- Construction of parallel 36-inch force mains via open cut.
- Other miscellaneous work.
