#### BOARD OF THE METROPOLITAN SEWERAGE DISTRICT August 20, 2025

#### 1. Call to Order and Roll Call:

The regular monthly meeting of the Metropolitan Sewerage District Board was held in the Boardroom of MSD's Administration Building at 2:00 pm, Wednesday, August 20, 2025. Chairman Vehaun presided with the following members present: Ashley, Bryson, Dearth, Lapsley, Manheimer, Pelly, Pennington, Player, Tarleton, Watts, Whitesides and Wisler. Moore was absent.

Others present were William Clarke, General Counsel; Forrest Westall, PE, with McGill Associates; Seth Eckard, Woodfin Sanitary Water & Sewer District; Tom Hartye, Hunter Carson, Scott Powell, Bart Farmer, Mike Stamey, Derrick Swing, Spencer Nay and Pam Nolan, MSD.

#### 2. Inquiry as to Conflict of Interest:

Mr. VeHaun asked if there were any conflicts of interest with the agenda items. No conflicts were reported.

#### 3. Approval of Minutes of the July 16, 2025 Board Meeting:

Mr. VeHaun asked if there were any changes to the Minutes of the July 16, 2025 Board Meeting. Mr. Watts moved for approval of the minutes as presented. Mr. Whitesides seconded the motion. Voice vote in favor of the motion was unanimous.

#### 4. Discussion and Adjustment of Agenda: None.

#### 5. Introduction of Guests:

Mr. VeHaun welcomed Seth Eckard with Woodfin Sanitary Water & Sewer District.

Mr. Hartye introduced Derrick Swing. Mr. Swing was recently hired to replace Pam Thomas as she retires as Personnel Director. Derrick has extensive experience as Personnel Manager and has worked with Brevard, City of Asheville and Sierra Nevada. Mr. Hartye stated MSD is extremely excited to have him on board. Mr. Swing stated that he is also excited to be here at MSD and he can already tell this is a great organization to be with.

#### 6. Informal Discussion and Public Comment: None.

#### 7. Report of Committees:

#### a. Right of Way Committee – July 23, 2025.

Mr. Ashley reported that the Right of Way Committee met on July 23, 2025 to consider compensation for three items. Right of Way Committee recommends accepting staff's recommendations on these three compensation budgets.

#### 8. Report of General Manager:

Mr. Hartye reported that Mike Stamey, System Services Director and Hunter Carson, Engineering Director will give a construction projects update for in-house and contracted projects.

Mr. Stamey began by highlighting the In-House Construction report which is included in the back of the Board package. This report shows projects that have been identified for construction for this coming year. Projects highlighted in green have been completed during the month of July and include 43 Woodfin Street, 51 Coxe Avenue, 286 Old Haw Creek Road and 112 Enthoffer Street Phase I, for a total of approximately 700 LF. Projects highlighted in yellow are current projects. 112 Enthoffer Street Phase II is located in Black Mountain and 37 Lucerne Avenue is located in West Asheville off of Patton Avenue. The projects in white are ones that have been identified as projects we are going to take on as we continue this coming year. Mr. Stamey then highlighted two recent repairs. The first was in Swannanoa near Whitson Avenue and involved a very close call with a missing manhole. This was a major area during the flood, and this repair was related to flood activities. The sewer line in this location is a 36-inch interceptor that transports a lot of the wastewater from the Black Mountain area back to the Water Reclamation Facility. Mr. Stamey presented slides and videos of the manhole buried under rocks, a large boulder wedged into the manhole, by-pass and repair work and completed work. The second project highlighted was at MSD's Weaverville Pump Station 1 off of Hidden Falls Drive and adjacent to Reems Creek. Mr. Stamey presented slides showing the old existing pump station, the force main that comes through the pump station and the location of an isolation valve previously used by operations. A call was reported on a Saturday morning regarding a leak at this pump station. Staff mobilized three work groups consisting of pump maintenance staff to watch and control the pump station, technical services staff with flush trucks that were going to be hauling wastewater from the site back to the plant, and construction staff to investigate and make the repair. The flush truck drivers hauled approximately 78,000 gallons of wastewater for a 5-mile trip back to the plant. He presented slides of the wet well set up, excavation, exposed valve assembly, repairs and completed work. Mr. Stamey stated that MSD is fortunate to have employees who will come in and get the job done when needed.

Mr. Carson began by continuing at the Weaverville Pump Station which is the same location Mr. Stamey reported on. MSD is in the process of replacing this entire station. This is a 2.8 mgd pump station at this time and will be replaced with a 5 mgd station which will be expandable beyond that as well. It has been sized for a 50-year flow projection. The 12-inch force main will also be replaced with a new 24-inch force main for increased capacity. Haren Construction has been working on this project for about a year. This is a \$24 Million job and is expected to be complete in a little less than a year. Mr. Carson presented slides and explained that the 30-inch Reems Creek interceptor comes into the existing pump station but will ultimately have to be re-routed to the new station. There will be a new 30-inch pipe that comes into the influent manhole and then the actual pump station itself. There will be two grinder channels and wastewater flow will come through one of two grinders that grind up large debris and solids that come in so they can be conveyed by the submersible pumps. There will also be a valve vault and a new electrical building

> and emergency generator. This structure is about 30-feet deep. Mr. Hartye stated that in one of the last presentations a slide was shown of equipment at the bottom of the hole after Helene that had to be removed by crane. Mr. Carson added that Haren Construction had been working for less than a month and had made a lot of progress until during the hurricane when Reems Creek came up so quickly that they lost an excavator. Mr. Carson reported on some materials the District likes to use on interceptor and force main projects and passed out a sample of them. Manhole components on this project are made of polymer concrete. Most of the District's manholes are precast concrete but these are a little special since being on an interceptor line. They don't use steel reinforcement, but a fiberglass reinforced plastic rebar and then an aggregate and resin combination. With the 30-inch interceptor that will be re-routed to the new pump station fiberglass reinforced plastic pipe will be used. This is completely resistant to hydrogen sulfide gas. Similarly on the force main we are using pvc pipe which is the C900 product and then also HDPE which is a high-density polyethylene pipe. The new pipe is primarily in the same trench as the existing force main which will require bypass pipe. During the force main bypass contractors have had to cross a few roads and driveways including Old Marshall Highway and Goldview Road. This project is progressing well and is on schedule for Summer 2026 completion.

> Mr. Carson then reported on the RBC Relocation Project at the Water Reclamation Facility. There are 3 RBC Basins and the flow goes from Basin 1 to Basin 3 downstream. About 1 ½ years ago there were some failed RBC units in Basin 1 and those were removed so we had some open cells. Historically, Basin 3 doesn't treat as well as Basin 1 because you don't have the microbial population that you do in Basin 1. MSD took this opportunity to relocate 9 RBC units from Basin 3 to Basin 1. Since this work was completed in June, Staff has seen a much more robust microbial population which equates to better wastewater treatment. Mr. Carson presented some slides and explained that some very large cranes needed to be used to relocate the units because they can sometimes be upwards of 60,000 pounds. Plant operations did a very good job of cleaning and drying them so that they didn't exceed 30,000 pounds this go round but we planned for 60,000 pounds. These cranes came in on a lot of trucks and it took about four days to put them together. Mr. Carson stated that he was told that after they put them all together they weighed about 1 million pounds each and there were two of them. During the four days of putting the cranes together, which had to be put together with cranes, Mr. Farmer and plant operations staff were draining the basins, preparing for relocation and what they found was a lot of debris left over from the hurricane. A lot of sand and silt came in as MSD treated river water for the majority of several weeks. Mr. Stamey's crews came in to help with removing all of the debris. Mr. Lapsley asked what they did with the debris. Mr. Carson stated that it is up on the hill near the lagoon being dewatered and will be taken to the landfill.

> Mr. Carson also reported on the Biological Treatment Pilot Testing which is small scale testing for biological treatment and is going to be the future replacement of the RBC Units. One of the processes being tested and are very interested in is AquaNereda. He presented photos of the pilot scale unit. MSD does have a future ammonia compliance deadline of 2037 so that is what we are working towards. It will be a very large project, upwards of \$400 Million, and MSD wants to make sure it will work so that is the purpose of this pilot testing. This has been in place since

December and it is doing what needs to be done in terms of ammonia removal so it will meet the future compliance limit. Staff is still working with the vendor on optimizing the system but it is removing ammonia.

Mr. Carson also reported on the Carrier Bridge Pump Station River Crossings located at the French Broad River Park. Cleary Construction mobilized and began in water work two weeks ago. The first of two river crossings will take place at the French Broad River Park and once that is done, Ruby-Collins, who is the contractor for the pump station project, will be mobilizing to install the pump station itself. Mr. Carson presented photos of the force main piping that will be installed underneath the river, and the coffer dam installation which has several weeks to go before completion. Ideally, they will be able to seal this up with a mixture of rock and earth. If not, they have aqua dams, which are big water bladders that they will put on the outside to seal against the river bottom. Staff is trying to get a lot of notice out to the public. There is signage at the park entrance, boat launches and various points along the Greenway. Staff has given multiple presentations to community groups trying to get the message out that the park is closed. There have been newspaper articles placed in the Asheville Citizen Times and Asheville Watchdog and there is a notification on the MSD Website. These signs have a QR Code on them that points back to the project's web page which we are trying to keep updated with major construction events. Work has been going on for a little over two weeks and people are still constantly coming through. Ms. Wisler asked, regarding the ammonia reduction, how many systems will be tested or has MSD decided on the vendor. Mr. Carson stated that MSD is down to three processes, and the membrane process is not easy to test. Right now, this is the only pilot that we intend to test. The others are fairly tried and true and the membranes are basically very tight filters so there is more confidence in that. What we are searching for here is a process that can not only remove ammonia but in a small footprint. Mr. Hartye stated that MSD was looking at several technologies but this one you can see on site. Mr. Lapsley asked if in the end there would be a sole source treatment process? Mr. Hartye stated that Hazen and Sawyer is doing the preliminary engineering report and this pilot testing is a part of that overall project. They first identified several technologies and whittled them down to three. Hunter and other staff have been visiting other areas to see how their projects are going and what the sizing is of some of these and we are looking for something that will fit in our footprint. The size needed for some of these technologies is just not economical. Hopefully at the end of the preliminary engineering report we will be able to identify which technology to go with. The intent is to have a design and build for this type of project so we can get the contractor involved. Mr. Lapsley stated his concern is that, when you get to the end, if it ends up being a sole source product, we are talking about multi-millions of dollars and want to make sure we are not held captive by the vendor to where we have designed the whole thing around one product and we would be stuck. Mr. Carson stated that AquaNereda trademarked the process a number of years ago but they do have at least one competitor.

Mr. Hartye reported that attached is an email from Divine Winds at 96 McLain Street regarding appreciation for quick and efficient service. Thanks to Stacey Frady, Samuel Gettleman and Grayson Hensley and crew.

Mr. Hartye reported that the August Right of Way Committee meeting has been cancelled. The next Right of Way Committee meeting will be held on September 24<sup>th</sup> at 9 am. The next regular Board Meeting will be held on September 17<sup>th</sup> at 2 pm. Mr. Hartye will be on vacation and Mr. Carson will be acting on his behalf for the September meeting.

#### 9. Consolidated Motion Agenda:

#### a. Consideration of Bids – Jonestown Road @ Riverside Drive:

Mr. Hartye reported that this project is located in Woodfin near the French Broad River and consists of approximately 2,222 LF of 8-inch to be installed with half being dig and replace and half by pipe bursting. The existing sewer lines are 6-inch VCP that are in poor condition. The project was advertised for formal bids and only two bids were received on July 31, 2025. Per General Statutes the project was readvertised and again two bids were received on August 7, 2025, as follows: Hinterland Group with a bid amount of \$1,263,690.00 and Terry Brothers Construction Company with a bid amount of \$722,690.00. The apparent low bidder is Terry Brothers Construction Company with a bid amount of \$722,690.00. Staff has been pleased with their previous performances. The FY 25-26 construction budget for this project is \$725,000.00. Staff recommends award of this contract to Terry Brothers Construction Company in the amount of \$722,690.00 subject to review and approval by District Counsel.

#### b. Consideration of Bids: Interceptor Line Assessment and Cleaning Phase 1:

Mr. Hartye reported that as a result of Hurricane Helene there was a lot of debris introduced into the system. This project includes CCTV, sonar inspection and line cleaning of approximately 83,000 LF of interceptor sewers ranging in size from 12-inch to 42-inch in diameter. Sonar inspection will identify debris levels and scope of cleaning. A second phase will be bid next fiscal year. MSD will seek FEMA reimbursement for this project. The project was advertised formally and three sealed bids were received on July 31, 2025 as follows: Hinterland Group with a bid amount of \$5,137,977.84; Compliance EnviroSystems LLC with a bid amount of \$2,440,450.72 and Bio-Nomic Services, Inc. with a bid amount of \$1,291,375.55. The apparent low bidder is Bio-Nomic Services, Inc. with a bid amount of \$1,291,375.55. Bio-Nomic Services, Inc. has prior experience with one District cleaning project and extensive overall experience in sewer CCTV and cleaning. The FY 25-26 construction budget for this project is \$2,590,000.00. Staff recommends award of this contract to Bio-Nomic Cleaning Services, Inc. in the amount of \$1,291,375.55 subject to review and approval by District Counsel.

#### c. Consideration of Reimbursement Agreement – 75 Cole Road Apartments:

Mr. Hartye reported that this is a proposed multi-family residential development with an attached reimbursement agreement for the rehabilitation of approximately 970 LF of existing 6-inch and 8-inch sewer lines near the intersection of I-26 and US25/70 in Weaverville. Basically from the Waffle House, under 2 ramps and I-26 and ending up near Lowes. During the course of

one day, the flows would get up to three-quarters full. In 2015, the District Board adopted a Reimbursement Policy. Based on the District's Master Plan, Staff has determined that this needs to be a 16-inch pipe. The District's cost participation is determined using a point-based system which is attached to this item. The system considers age of pipe, pipe size, ratio of existing vs. proposed development flow, distance from proposed development to the undersized pipe segments. The District's participation amount is 50% of the project, or \$983,150.00. This project is not anticipated to occur until FY26-27 or later. Staff recommends the District enter into a reimbursement agreement with Caviness & Cates Communities in the amount of \$983,150.00, subject to review and approval by District Counsel.

# d. Consideration of Compensation Budgets – Carrier Bridge Pump Station; Hazel Mill Road @ Richland Street and 28 Vista Street:

Mr. Hartye reported the Right of Way Committee recommends approval of these compensation budgets.

# e. Consideration of Developer Constructed Sewer Systems – Woodfield (RAD Lofts); The Meridian; Montinail Land Company:

Mr. Hartye reported that the Woodfield (RAD Lofts) project is located along Roberts Street in the City of Asheville and included extending approximately 403 linear feet of 8-inch public gravity sewer to serve 235 Multi-Family apartments and approximately 18,000 square feet of retail space.

Mr. Hartye reported that the Meridian project is located along Long Shoals Road in the City of Asheville and included extending approximately 400 linear feet of 8-inch public gravity sewer to serve 201Multi-Family apartments.

Mr. Hartye reported that the Montinail Land Company project is located along US-70 Highway in Buncombe County and included extending approximately 440 linear feet of 8-inch public gravity sewer to serve 9 Multi-Family units and Commercial Buildings on site.

Staff recommends acceptance of the aforementioned developer constructed sewer systems. All MSD requirements have been met.

#### f. Fourth Quarter Budget to Actual Review 2025:

Mr. Powell reported that Domestic and Industrial Revenue are above budgeted expectations. In June, the Board approved a \$4.3 Million Budget Amendment to reduce domestic revenues based on the effects of Tropical Storm Helene. Staff believes Domestic User Fee variance will end up around 105% when June accounts receivable data is received from its Member Agencies in September. Industrial Revenue is trending better than budgeted expectations due to a temporary increase in revenue from short-term industrial users. Staff monitors consumption trends as they have a direct effect on the District's current and future revenue projections. Facility and Tap Fees are above budgeted expectations. This is due to the District receiving an additional \$4 Million from various developers.

Interest and miscellaneous income are above budgeted expectations due to actual short-term interest rates exceeding anticipated yields for the fiscal year. Additionally, the District received approximately \$730,000.00 from FEMA as of June 30. O&M Expenditures are at 91.6% of budget. This is taking into consideration the Budget Amendment in June of \$250,000.00. This amount may vary slightly from audited numbers due to final accruals. Bond principal and interest and other long-term obligations are at budgeted expectations. Capital Project expenditures are at approximately 72.8% of budget. This reflects delays in projects. All unexpended funds have been included in the FY26 Budget.

#### g. Reimbursement Resolution for Bond Projects:

Mr. Powell reported that to be in compliance with IRS Regulations concerning tax exempt financing, all expenditures made with non-MSD bond funds and to be reimbursed from MSD bond funds must be properly identified and authorized. The proposed reimbursement resolution identifies major projects intended to be solely or substantially financed by bonds anticipated to be issued in FY27. Board approval is required to obtain tax exemption of interest paid on MSD bonds by authorizing reimbursement from bond proceeds of the expenditures for the attached project listing.

#### h. Cash Commitment Investment Report – Month ended June, 2025:

Mr. Powell reported that Page 53 presents the makeup of the District's Investment Portfolio. There has been no significant change in the makeup of the portfolio from the prior month. Page 54 presents the MSD Investment Manager's report as of the month of June. The weighted average maturity of the investment portfolio is 111 days. The yield to maturity is 4.25%. Page 57 presents MSD's Variable Debt Service report. The 2008 Series Bonds are performing at budgeted expectations. As of the end of July, the issue has saved the District's rate payers approximately \$8 Million in debt service since April, 2008.

With no further discussion, Mr. VeHaun called for a motion to approve the Consolidated Motion Agenda. Mr. Pennington moved, Ms. Wisler seconded the motion. Roll call vote was as follows: 13 ayes; 0 Nays.

#### 10. Old Business:

Mr. Watts asked Mr. Carson about the status of the power plant. Mr. Carson stated that Staff met with American Rivers four to five months ago. Staff communicated to them what we thought was fair for reimbursement, which was estimated based off of a 30-year projection of what would offset the cost of the power. Staff has not heard much from them since. Mr. Watts asked if the powerhouse and facilities were damaged during the storm. Mr. Carson stated no, not due to the storm. There was what appeared to be a lightning strike prior to the storm but no damage from the storm itself. Everything has been back up and running for a couple of months.

#### 1. Call to Order and Roll Call:

Chairman Vehaun presided with the following members present: Ashley, Bryson, Dearth, Manheimer, Pennington, Tarleton, Watts and Whitesides. Lapsley, Moore, Pelly, Player and Wisler were absent.

Others present were William Clarke, General Counsel; Patty Beaver with CIBO; Derek Allen and Jesse Swords with Ask Law; Forrest Westall, PE, with McGill Associates; Tom Hartye, Hunter Carson, Scott Powell, Bart Farmer, Mike Stamey, Schuyler Taylor, Spencer Nay and Pam Nolan, MSD.

#### 2. Inquiry as to Conflict of Interest:

Mr. VeHaun asked if there were any conflicts of interest with the agenda items. No conflicts were reported.

#### 3. Approval of Minutes of the June 11, 2025 Board Meeting:

#### 7. Election of Officers:

Mr. VeHaun called for nominations for Chair of the MSD Board. Mr. Watts nominated Mr. VeHaun as Chair. Mr. Ashley seconded the nomination. With no further nominations, Mr. VeHaun called for a motion that nominations be closed and that, by acclamation, Mr. VeHaun be elected as Chair of the MSD Board for 2025-2026. Mr. Watts moved, and Mr. Whitesides seconded the motion. Roll call vote was as follows: 9 ayes; 0 Nays.

Mr. VeHaun called for nominations for Vice Chair of the MSD Board. Mr. Ashley nominated Mr. Whitesides as Vice Chair. Mr. Pennington seconded the nomination. Mr. VeHaun called for a motion that nominations be closed and that, by acclamation, Mr. Whitesides be elected as Vice Chair of the MSD Board for 2025-2026. Mr. Watts moved, and Ms. Manheimer seconded the motion. Roll call vote was as follows: 9 ayes; 0 Nays.

Mr. VeHaun appointed Ms. Bryson for re-appointment as Secretary/Treasurer of the MSD Board for 2025-2026. Roll call vote was as follows: 9 ayes; 0 Nays.

#### 8. Report of General Manager:

Mr. Hartye reported that the bids for Carrier Bridge Pump Station are on the agenda. This is the largest and most expensive project (\$94 Million) that MSD has undertaken in the last 40 years. As a reminder, we have separated this project into two projects for the sake of expediting the construction disturbance and facilitate restoration of French Broad River Park and Carrier Park. The first portion is the "Pipeline River Crossings" project consisting of two open cut river crossings to install new pipelines for the future. Since this portion of the project will affect the central area of both parks, it was carved out and was awarded at our March 19th Board Meeting. The contractor is currently mobilizing equipment and materials to the site. Mr. Hartye presented slides on this project from previous meetings as a refresher. On the Agenda today is the Pump Station itself and appurtenant connector lines and is located primarily adjacent to the French Broad River Park with lines extending into the park. This project will take approximately 3 years to complete. MSD Staff has been working closely with the City of Asheville staff to coordinate our efforts to expedite the reopening of parks and usable portions thereof. Ms. Manheimer asked what the timeline for the portion for Carrier Park to Amboy Bridge is. She stated that the City would be working on their part if the District could work with them. Mr. Carson stated that portion is at the end of the 10-year CIP and is about a 33,000 LF project estimated at approximately \$50 million in its entirety but Staff could maybe look at doing a shorter section with the City. There was discussion regarding these areas already getting a lot of use. There will be a need to cordon off these areas during this project.

Mr. Hartye reported that the next Right of Way Committee meeting will be held on July 23<sup>rd</sup> at 9 am. The next regular Board Meeting will be held on August 20<sup>th</sup> at 2 pm.

#### 9. Consolidated Motion Agenda:

#### a. Consideration of Bids - Carrier Bridge Pump Station Replacement Project:

Mr. Hartye reported that this project was formally advertised and three bids were received on June 25, 2025 as follows: Kiewit Infrastructure South Co. with a bid amount of \$108,621,660.00; Thalle Construction Company with a bid amount of \$83,457,850.00; and Ruby-Collins, Inc. with a bid amount of \$75,378,958.00. The apparent low bidder is Ruby-Collins, Inc. with a bid amount of \$75,378,958.00. The bid amounts include an allowance for a pre-negotiated scope and fee for System Integration Services and also includes an Alternate bid item "A" for upgrading to Flygt submersible wastewater pumps in lieu of KSB pumps. Ruby-Collins has a proven track record working for the District. They have had several projects they have completed successfully. In addition, HDR, the District's design engineer for this project, conducted reference checks for similar pump station projects and received positive feedback for each reference. The construction budget for this multi-year project is \$104 Million, with \$14 Million in expenditures slated for FY25-26, and that includes the two river

crossings. Staff recommends award of this contract to Ruby-Collins, Inc. in the amount of \$75,378,958.00, subject to review and approval by District Counsel.

### b. Consideration of Bids: Old County Home Road Private Sanitary Sewer Rehabilitation Project:

Mr. Hartye reported that this project is located in western Buncombe County on Old County Home Road. The project consists of over 4,000 LF of 18-inch, 12-inch and 8-inch pipe crossing under New Leicester Highway to connect to the Erwin Hills Pump Station force main. The project was formally advertised and two bids were received on June 26, 2025. Per NC General Statutes, the project was re-advertised and two sealed bids were received on July 3, 2025 as follows: Teraflex Group with a bid amount of \$4,308,542.00 and Terry Brothers Construction Company with a bid amount of \$2,874,835.00. The apparent low bidder is Terry Brothers Construction Company with a bid amount of \$2,874,835.00. Terry Brothers has extensive experience with District rehabilitation projects and have done very well. The FY25-26 construction budget for this project is \$3,033,000.00. Staff recommends award of this contract to Terry Brothers Construction Company, subject to review and approval by District Counsel.

# c. Consideration of Informal Bids: Incinerator Sand Transport System Replacement:

Mr. Hartye reported that this project is located at the District's Water Reclamation Facility and includes replacement of the incinerator sand storage and transport system. This system is responsible for conveying sand from an externally located storage silo into the incinerator. The District's fluidized bed incinerator used sand to disperse and transfer heat to the biosolids prior to combustion. This replacement project includes removal of the existing system and installation of a larger storage silo, larger transporter, larger diameter conveyance line, and a new control panel. Due to long lead time, the replacement equipment was pre-purchased under separate contract (with Dynamic Air, Inc.) and approved by this Board on August 21, 2024. The equipment is now in MSD's possession. This contract is for removal of the existing system and installation of the new. The project was advertised informally on June 26, 2025, and two bids were received as follows: Cove Utility with a bid amount of \$219,300.00 and Haynes Industrial with a bid amount of \$85,400.00. The apparent low bidder is Haynes Industrial with a bid amount of \$85,400.00. Haynes Industrial has completed several projects at the District's WRF in the past and have performed very well. The FY 25-26 construction budget for this project is \$125,000.00. Staff recommends award of this contract to Haynes Industrial.

# d. Consideration of Informal Bids: Avon Avenue @ Haywood Road Sewer Rehabilitation Project:

Mr. Hartye reported this project is located in West Asheville near Avon Avenue and is comprised of 218 LF of 8-inch pipe. The project was advertised informally and two bids were received on June 26, 2025 as follows: Keys Construction with

a bid amount of \$212,105.00 and Terry Brothers Construction Co. with a bid amount of \$105,037.00. The apparent low bidder is Terry Brothers Construction Co. with a bid amount of \$105,037.00. Terry Brothers has extensive experience with District rehabilitation projects and continues to provide excellent workmanship. The FY 25-26 construction budget for this project is \$147,000.00. Staff recommends award of this contract to Terry Brothers Construction Company.

### e. Consideration of Developer Constructed Sewer Systems – Biltmore Terrace Phase 4; Randolph Avenue:

Mr. Hartye reported that the Biltmore Terrace Phase 4 project is located along Loblolly Lane in Buncombe County and included extending approximately 385 linear feet of 8-inch public gravity sewer to serve 7 Single-Family Residences.

Mr. Hartye reported that the Randolph Avenue project is located along Randolph Avenue in Black Mountain and included extending approximately 650 linear feet of 8-inch public gravity sewer to serve 2 Commercial Buildings and 6 Single-Family Residences.

Staff recommends acceptance of the aforementioned developer constructed sewer systems. All MSD requirements have been met.

#### f. Cash Commitment Investment Report – Month ended May, 2025:

Mr. Powell reported that Page 38 presents the makeup of the District's Investment Portfolio. There has been no significant change in the makeup of the portfolio from the prior month. Page 39 presents the MSD Investment Manager's report as of the month of May. The weighted average maturity of the investment portfolio is 114 days. The yield to maturity is 4.27%. Page 40 presents the MSD analysis of cash receipts. Monthly and YTD Domestic User Fees are considered reasonable based on timing of cash receipts and impacts of Tropical Storm Helene. Industrial User Fees are considered reasonable based on timing of cash receipts and historical trends. YTD Facility and Tap fees are above historical trends due to timing of various cash receipts from developers as well as these fees being budgeted conservatively. Page 41 presents MSD's Analysis of Expenditures. O&M, Debt Service and Capital Project expenditures are considered reasonable based on timing of cash expenditures and impacts of Tropical Storm Helene. Page 42 presents MSD's Variable Debt Service report. The 2008 Series Bonds are performing at budgeted expectations. As of the end of June, the issue has saved the District's rate payers approximately \$8 Million in debt service since April, 2008.

They have over 50 trained technicians, and the resources of a much larger nationwide parent company, the Carylon Corporation. In the past 3 years, Carylon Corporation has cleaned and televised over 61,000,000 LF of pipe with 356 crews covering 44 states. Bio-Nomic provided evidence of ownership of numerous Jetter trucks and CCTV equipment. Recent project experience includes sewer CCTV and cleaning projects varying from 500 LF to 240,000 LF. Much of their project experience is ≤24" diameter pipe with several noted projects in the larger pipe sizes. The designated supervisor has over 10 years' experience in similar projects. Bio-Nomic provided evidence of only four sonar related projects in the past five years but also has the resources of the parent company to draw upon. Three supportive references are described below. In summary, Bio-Nomic appears to have the necessary experience, positive references, and resources to successfully complete this MSD line assessment and cleaning project.

#### Reference No. 1:

Jason Foster, Director Water and Wastewater, Erwin Utilities. – Overall Rating 5/5.

Bio-Nomic completed 24,000 LF of sewer cleaning and CCTV for post Helene Recovery for Erwin Utilities. 10,000 LF of the total was 24" interceptor lines. They successfully handled removal of some large, accumulated material from the lines. Erwin Utilities had also contracted Bio-Nomic for additional similar projects over several previous years. Bio-Nomic reportedly had the appropriate equipment, skills, and professionalism to successfully complete the jobs in a thorough and timely manner. Bio-Nomic did a great job coordinating with staff and homeowners. The rating of 4/5 was due to brief equipment breakdowns. Mr. Moore generally had high praise for the company.

Taylor Withers, P.E., Project Manager, Sanders Utility Construction Co, Inc. – Overall Rating 5/5. Bio-Nomic has been used by this contractor many times over several years for City of Charlotte contracts for various stormwater and sewer lines of varying sizes (4" – 60" diameter for >240,000 LF). Most of the lines were new install. CCTV and some cleaning was conducted. Bio-Nomic reportedly had the appropriate equipment, skills, and professionalism to successfully complete the jobs in a thorough and timely manner. Mr. Withers indicated he gives Bio-Nomic his "full endorsement."



**BACKGROUND:** This reimbursement agreement is for the rehabilitation of approximately

970LF of existing 6-inch and 8-inch sewer lines near the intersection of I-26 and US25/Hwy70 in Weaverville. Under average day flow conditions, water level inside the existing pipes approaches three-quarters full. Wastewater flow from the proposed 75 Cole Road Apartment project (located upstream) will create conditions that exceed pipe capacity, requiring an upgrade. The development has an approved wastewater allocation of 56,100gpd for the two hundred twenty (220) multi-family

residential units planned.

In 2015, the District Board adopted a Reimbursement Policy applicable to the *Rehabilitation of Existing Sewer Lines* where the District will participate in an extension that connects to an existing sewer line which, in the opinion of the District, requires improvement with larger diameter pipe to provide adequate capacity. District staff has determined that the existing 6-inch and 8-inch piping mentioned above needs to be upsized to 16-inch pipe.

The District's cost participation is determined using a point-based system that considers age of pipe, pipe size, ratio of existing vs. proposed [development] flow, and distance from proposed development to the undersized pipe segment(s). The Cost Participation Worksheet yielded a District participation amount of 50%, or \$983,150.00. Total project cost as estimated by District staff is approximately \$1,966,300.00.

Please refer to the attached documentation for further details.

FISCAL IMPACT: The FY25-26 CIP budget includes \$100,000.00 for developer

reimbursement projects. The proposed reimbursement payment of \$983,150.00 will not be issued to the developer until the 16-inch pipe is complete, fully closed out, and accepted by the District Board as a public system. This is not anticipated to occur until FY26-27, or later. Funds will

be rebudgeted accordingly in the FY26-27 CIP Budget.

STAFF RECOMMENDATION: Staff recommends that the District enter into a

reimbursement agreement with Caviness & Cates Communities, in the amount of \$983,150.00, subject to

review and approval by District Counsel.

THIS AGREEMENT, made this \_\_\_\_\_\_\_ day of \_\_\_\_\_\_\_, 2025, by and between the METROPOLITAN SEWERAGE DISTRICT OF BUNCOMBE COUNTY (hereinafter sometimes called "MSD" or the "District"), a North Carolina public body and body politic and corporate created and established under the provisions of the North Carolina Metropolitan Sewerage Districts Act, Chapter 153, Article 25, Sections 153-295 to 153-324, inclusive (succeeded by Chapter 162A, Article 5, Sections 162A-64 to 162A-81, inclusive) of the General Statutes of North Carolina; with an office and place of business at 2028 Riverside Drive, Woodfin, in Buncombe County, North Carolina, and Caviness & Cates Communities (hereinafter "CCC") a corporation organized under the laws of the State of North Carolina with an office and place of business at 639 Executive Place Suite 400, Fayetteville, NC 28305;

WHEREAS, MSD maintains and operates a system of interceptor and collector sewer lines sometimes herein referred to as the "District Sewerage System"; and

WHEREAS, the District, in May 2015, adopted a Reimbursement Policy applicable to the Rehabilitation of Existing Sewer Lines (the "Policy") wherein the District will participate in an extension that connects to an existing sewer line which, in the opinion of the District, requires improvement with larger diameter pipe to provide adequate capacity; and

WHEREAS, the District's Policy includes a Cost Participation program wherein the District will participate in the cost of sewer improvements based on a point system; and

WHEREAS, CCC intends to develop a parcel located at 75 Cole Road in northern Buncombe County (PIN 9743-35-2359) and extend the District Sewerage System to serve the property; and

WHEREAS, MSD issued a wastewater allocation approval to CCC in the amount of 56,100 gallons per day for the two hundred twenty (220) multi-family residential development with a condition of said allocation being that a portion of existing 6-inch and 8-inch MSD sewer lines be upgraded with new 16-inch gravity sewer to provide sewer service for the new development; and

WHERAS, the existing 6-inch and 8-inch sewer lines to be upgraded to 16-inch are shown in "Exhibit A", attached hereto; and

WHERAS, CCC petitioned the **District** to participate in the cost of the sewer line upgrade required by MSD; and

WHERAS, MSD determined that CCC would qualify for cost participation; and

WHERAS, MSD completed the Cost Participation Worksheet, attached hereto as "Exhibit B" and determined that MSD will participate up to 50 percent of the cost of the required sewer rehabilitation; and

WHERAS, MSD engineering staff has estimated the cost of sewer rehabilitation for said upgrade to be \$1,966,300.00; and

WHERAS, the District will participate up to \$983,150.00 not to exceed 50 percent of the lesser amount of the MSD cost estimate or actual sewer construction cost; and

WHERAS, the District Board considered the petition to participate in the Sewer Rehabilitation Cost Participation, and approved the project for cost participation at the August 20, 2025 MSD regular Board meeting and agreed to a cost participation of 50 percent up to \$983,150.00, subject to compliance with all District requirements; and

**Now, Therefore,** in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and the covenants and conditions set forth herein, **MSD** and **CCC** hereby agree as follows:

- 1. CCC agrees to pay all engineering design costs associated with said 16-inch sewer line. CCC agrees to obtain and pay for any necessary permits for the construction of the 16-inch sewer line including any necessary encroachment agreements from the North Carolina Department of Transportation ("NCDOT").
- 2. CCC agrees to hire a public utility contractor currently licensed in the State of North Carolina to construct the 16-inch sewer line within the controlled access right of way of Interstate 26 in accordance with applicable permits from NCDOT. The contractor shall have prior successful experience with MSD rehabilitation projects and shall be approved by MSD.
- 3. MSD agrees to acquire any offsite easements including access easements necessary for the construction of the 16-inch sewer line at MSD's sole expense. This shall include the preparation of Easement Plats, legal fees, recording fees and any compensation paid in exchange for any required offsite easements. Any required offsite easements shall be in place before work begins as outlined in condition one above.
- 4. The 16-inch gravity sewer system will be constructed in a good and workmanlike manner, in accordance with plans and specifications prepared by Civil Design Concepts, PA and approved by MSD, and requirements of the non-discharge permit issued by MSD for the sewer extension. Approved plans and non-discharge permit have not been issued.
- 5. CCC and MSD acknowledge and agree that MSD will pay 50% of actual sewer construction cost not to exceed \$983,150.00. MSD and CCC agree that MSD shall make no additional reimbursement or payments to CCC except as set forth in this Agreement.

- 6. **MSD** agrees to reimburse **CCC** the amount set forth in Paragraph 3 upon completion of the new 16-inch gravity sewer. Full completion shall be defined as:
  - All construction and testing is 100% complete and passing in accordance with MSD specifications.
  - 2) All applicable permitting requirements have been met.
  - 3) All restoration on properties except **CCC's** is 100% complete including the NCDOT public right of way.
  - 4) Submission of all final closeout documents including:
    - Engineer's Certification
    - Engineering As-Built Drawings
    - Survey Easement Plats (if applicable)
    - Contractor's Certification to include one-year warranty
    - MSD Final Inspection Approval
    - Conveyance of Sewer System
  - 5) Conveyance of the gravity sewer system and easements therefore to **MSD** and acceptance of the same by the MSD Board of Directors.

Completion shall be determined by **MSD Planning and Development Section.** Upon project completion, **MSD** shall notify **CCC** in writing of such satisfactory completion of the work and **MSD** shall thereafter reimburse **CCC** as provided in Paragraph 5.

- 7. MSD will employ construction inspectors, at its expense, to inspect the construction of the 16-inch gravity sewer system. CCC and its contractor further agree to coordinate all sewer construction activities with MSD to facilitate timely completion and restoration of affected areas.
- 8. Change(s) to the project made in the field must be reviewed and approved by **MSD** prior to implementation. It shall be the responsibility of **CCC** and its contractor to make **MSD**'s Construction Division aware of any proposed change(s) and to obtain approval for the change(s) from **MSD**. Upon receipt of a request for change(s) in the project design and/or

construction, **MSD** will promptly review such change(s) and shall indicate approval or denial of such change(s) within reasonable time of receipt thereof and not more than three (3) business days. Any proposed change(s) which may affect the quality of the design, the integrity of the sewer system, additional costs to **MSD** or any matter involving right of way revisions shall be submitted in writing by **CCC** and shall be approved/disapproved in writing by **MSD** within three (3) business days of receipt. To the extent such change(s) increase the cost of the 16-inch gravity sewer system, **MSD** and **CCC** shall mutually agree upon additional reimbursement to **CCC**, if any for such increase in cost.

- 9. Upon completion of construction, CCC will convey the 16-inch gravity sewer system and easements for the same to MSD. Such conveyance will be prepared by CCC attorney using an instrument in form and content similar to Exhibit C, attached hereto. Upon finding the conveyance is in accord with relevant provisions of its bond order and applicable law, MSD will issue approval to record conveyance and subsequently accept the conveyance of the 16-inch gravity sewer system.
- 10. This agreement shall be governed by and under the laws of the State of North Carolina. Any litigation hereunder shall be in the General Court of Justice for the 28<sup>th</sup> Judicial District of North Carolina.
- 11. This Agreement represents the entire agreement between **MSD** and **CCC** with respect to the subject matter hereof. Any amendment to this agreement shall be in writing and signed by the parties hereto.



The total compensation budget on the Hazel Mill Road @ Richland Street GSR project is over budget by \$19,179. Since this is a multiyear project, the compensation budget will be adjusted accordingly during the FY 26-27 budget.

#### STAFF RECOMMENDATION: Approval of Compensation Budgets.

Mr. Banner reviewed the above compensation budgets.

The Carrier Bridge Pump Station project consists of rehabilitating 48-inch and 54-inch RCP, and replacing 24-inch force main, 10" DIP and 8-inch VCP. The existing pump station is under capacity.

The compensation budget for Hazel Mill Road @ Richland Street is over by \$19,179.00. Since this is a multiyear project, the compensation budget will be adjusted accordingly during the FY 26-27 budget. This project consists of replacing existing 6-inch VCP that is undersized and has multiple structural defects, with 3,857 linear feet of 8-inch DIP.

The 28 Vista Street project consists of replacing 6-inch VCP that is in poor condition with significant root intrusion with 932 linear feet of 8-inch DIP.







Subject: Fourth Quarter Budget to Actual Review – FY2025

#### Background

At the end of each quarter, actual revenue and expenditure amounts are compared with the budget to evaluate performance. This information is based on cash revenues and invoices received prior to June 30, 2025 and may not include some accruals of revenue and expenditures.

#### Discussion

There are several explanatory notes at the bottom of the attached Budget to Actual schedule.

#### Other considerations are as follows:

- Domestic and Industrial revenues are above budgeted expectations. In June, the board approved a \$4 million budget amendment to reduce domestic revenues based on the effect of Tropical Helene. Staff believe Domestic User Fee variance will end up around 105% when June account receivable data is received from its Member Agencies. Industrial Revenue is trending better than budgeted expectations due to temporary increased revenue from short-term industrial users. Staff monitor consumption trends as they have a direct effect on the District's current and future revenue projections.
- Facility and Tap Fees are budgeted conservatively. The unusually large variance as of the end of the year is due to receiving unanticipated revenue from various developments.
- Interest and miscellaneous income are above budgeted expectations. Actual short-term interest rates exceeded anticipated yields for the fiscal year. Additionally, the District received approximately \$730,000 from FEMA.

#### Discussion (continued)

- Rental income reflects actual cash receipts.
- Actual and encumbered 0&M expenditures are considered reasonable but may vary slightly once accruals and adjustments are made in connection with the final audit.
- Bond principal and interest are at budgeted expectations.
- Capital project expenditures are approximately 72.82% of budget. This reflects delays in projects. All unexpended funds have been included in the FY2026 budget.
- > For presentation purposes, staff have reflected all costs pertaining to tropical storm Helene under the contingency line item. Staff believe all costs will be reimbursed through a combination of insurance and FEMA reimbursement.

Subject: Reimbursement Resolution for Bond Projects

#### **Background**

To be in compliance with IRS regulations concerning tax-exempt financing, all expenditures made with non-MSD bond funds and to be reimbursed from MSD bond funds must be properly identified and authorized. The proposed reimbursement resolution identifies major projects intended to be solely or substantially financed by bonds anticipated to be issued in FY2027. Board approval is required to obtain the tax-exemption of interest paid on MSD bonds by authorizing reimbursement from bond proceeds of the expenditures for these projects.

This resolution does not take the place of an annual budget or capital projects ordinance as mandated by North Carolina General Statutes required authorizing any expenditures irrespective of source of the funds. These projects have been or will be included in the District's annual budget process.

In addition to this current reimbursement resolution, additional resolutions may be submitted for other projects when their anticipated costs may be more accurately projected.

#### Discussion

\$80 million of bonds are planned to be issued in FY2027 and this reimbursement resolution is intended to preserve for the District the ability to issue the bonds as tax-exempt bonds and to reimburse itself from their proceeds for the temporary cash outlay made for the projects identified in the reimbursement resolutions.

Engineering staff have identified several upcoming projects detailed on the attached exhibit, which could be reimbursed from the upcoming revenue bonds. Estimated reimbursable expenditures for these projects total \$37,750,000.

## REIMBURSEMENT RESOLUTION

RESOLUTION OF THE DISTRICT BOARD OF THE METROPOLITAN SEWERAGE DISTRICT OF BUNCOMBE COUNTY, NORTH CAROLINA DECLARING ITS INTENTION TO REIMBURSE ITSELF FROM THE PROCEEDS OF ONE OR MORE TAX-EXEMPT FINANCINGS FOR CERTAIN EXPENDITURES MADE AND/OR TO BE MADE IN CONNECTION WITH THE ACQUISITION, CONSTRUCTION AND/OR EQUIPPING OF CERTAIN CAPITAL IMPROVEMENTS

WHEREAS, the Metropolitan Sewerage District of Buncombe County, North Carolina (the "Issuer") is a body politic and corporate organized and existing under the laws of the State of North Carolina; and

WHEREAS, the Issuer has paid, beginning June 20, 2025, and will pay, on and after the date hereof, certain expenditures (the "Expenditures) in connection with the acquisition, design and construction of the projects on the attached Exhibit (the "Projects"); and

WHEREAS, the District Board of the Issuer (the "Board") has determined that those monies previously advanced no more than 60 days prior to the date hereof and to be advanced on and after the date hereof to pay the Expenditures are available only for a temporary period and it is necessary to reimburse the Issuer for the Expenditures from the proceeds of one or more issues of tax-exempt bonds (the "Bonds");

#### NOW, THEREFORE, BE IT RESOLVED BY THE BOARD AS FOLLOWS:

- Section 1. The Board hereby declares the Issuer's intent to reimburse the Issuer with the proceeds of the Bonds for the Expenditures with respect to the Project made on and after June 20, 2025 which date is no more than 60 days prior to the date hereof. The Issuer reasonably expects on the date hereof that it will reimburse the Expenditures with the proceeds of the Bonds.
- Section 2. Each Expenditure was and will be either (a) of a type properly chargeable to capital account under general federal income tax principles (determined in each case as of the date of the Expenditure), (b) a cost of issuance with respect to the Bonds, (c) a nonrecurring item that is not customarily payable from current revenues, or (d) a grant to a party that is not related to or an agent of the Issuer so long as such grant does not impose any obligation or condition (directly or indirectly) to repay any amount to or for the benefit of the Issuer.
- Section 3. The maximum principal amount of the Bonds expected to be issued for the Projects is \$37,750,000.
- Section 4. The Issuer will make a reimbursement allocation, which is a written allocation by the Issuer that evidences the Issuer's use of proceeds of the Bonds to reimburse an Expenditure, no later than 18 months after the later of the date on which the Expenditure is paid or the Projects are placed in service or abandoned, but in no event more than three years after the date on which the Expenditure is paid. The Issuer recognizes that exceptions are available for certain "preliminary expenditures," costs of issuance, certain de minimis amounts, expenditures by "small issuers" (based on the year of issuance and not the year of expenditure) and expenditures for construction projects of at least five years.
- Section 5. This resolution shall take effect immediately upon its passage.
