ADVERTISEMENT FOR BIDS

Sealed bids will be received by the Metropolitan Sewerage District (DISTRICT) of Buncombe County, North Carolina at the 2nd floor conference room of the MSD W. H. Mull Building, 2028 Riverside Drive in Asheville, North Carolina, until 2:00 PM (local time), Thursday, December 5th, 2024, and shall be immediately opened publicly and read aloud for the project described as follows:

Incinerator Rehabilitation Materials Purchase Project No. 2022057

The project shall generally consist of the Supplier furnishing materials that will be installed by others in the incinerator building at the Metropolitan Sewerage District's French Broad River Water Reclamation Facility in Asheville, NC (WRF). The installation of said materials shall be performed under a separate contract.

A pre-bid conference will not be held.

All known bidders will be sent written copies of questions that require a written response or a change to the requirements and/or specifications. In the event of a major change to requirements and/or specifications, MSD reserves the right to postpone the bid opening, with advance notice to all known bidders.

If a bid is being mailed or emailed, it is recommended that they be sent in a manner to insure receipt at MSD by Wednesday, December 4th. Mailed bids shall be addressed as follows:

Each bid shall be accompanied by a deposit with the Metropolitan Sewerage District of Buncombe County of cash, or a cashier's check, or a certified check on some bank or trust company insured by the Federal Deposit Insurance Corporation in an amount equal to not less than five percent (5%) of the bid amount. In lieu of making the cash deposit as above described, a satisfactory Bid Bond in the amount of 5% of the total bid, executed by a corporate surety licensed under the laws of North Carolina to execute such bonds, shall be submitted with each bid, conditioned that the surety will upon demand forthwith make payment to the obligee upon said bond if the bidder fails to execute the contract in accordance with the bid bond. This deposit shall be retained if the successful bidder fails to execute the contract within ten (10) days after the award of bid or fails to give satisfactory surety as required in North Carolina General Statute Section 143-129.

The successful bidder will be required to furnish a Performance Bond in the amount of one hundred percent (100%) of the contract amount. Those bonds shall meet the requirements of North Carolina General Statute Section 143-129 and of Article 3 of Chapter 44A of the North Carolina General Statute.

No bid may be withdrawn after bids have been opened, except as provided in <u>North Carolina</u> General Statute Section 143-129.1.

The contract shall be awarded to the lowest responsive, responsible bidder, taking into consideration quality, performance and time of delivery. The DISTRCT reserves the right to reject any and all bids, including, without limitation, the right to reject any or all non-conforming, non-responsive, unbalanced or conditional bids, and to reject the bid of any bidder if the DISTRICT believes that it would not be in the best interest of the DISTRICT to make an award to that bidder. The DISTRICT also reserves the right to waive informalities.

INCINERATOR INTERIOR MATERIALS

GENERAL BACKGROUND

The Metropolitan Sewerage District of Buncombe County, North Carolina (DISTRICT) is soliciting Request for Quotations for fireclay brick and castable refractory material to rehabilitate the dome floor of the fluidizing bed incinerator (FBI) at DISTRICT's Water Reclamation Facility (WRF). The FBI is the DISTRICT's primary means of sanitary sewer solids disposal at the WRF. The existing FBI was originally placed into service in 1992 and underwent a major rebuild in 2004.

SCOPE OF WORK

The scope of the work shall include all materials for replacement of the FBI's existing dome floor "special shape" fireclay brick and castable refractory materials. The quantities and dimensions for each item shall be determined by supplier based on the 2004 Hankin "Modification to Fluidized Bed Incinerator" drawings provided by MSD. Supplier shall furnish all materials as specified herein. The installation of the said materials shall be performed under a separate contract.

GENERAL

- A. Furnish all "special shape" fireclay brick, extra strength castable, and extreme temperature castable to rebuild FBI dome floor complete starting at the bottom of the floor (elev. 1952.22) and terminating at the top, below the start of the corbel wall section (elev. 1954.67) as shown on drawings.
 - 1. The fireclay brick material dimensions and quantity shall be determined by the drawings and as specified herein. The fireclay brick shall be manufactured to include the appropriate tuyere holes size and location. The fireclay brick shall meet or exceed all ASTM Standards.

 - Apparent porosity max. of 18%
 - Crushing strength min. of 4,000 lbs/in² at 70°F
 - Modulus of rapture min. of 1,200 lbs/in² at 70°F

abrasion, spalling, and vitrification and withstand temperatures up to 2,550°F. The castable material shall meet or exceed all ASTM Standards.

- The extreme temperature castable refractory material shall be Mizzou 60% Alumina, Mizzou Plus 60% Alumina Castable or approved equal.
- B. Other materials will be required to construct the dome floor. These remaining materials will be associated with a separate contract.
- C. The supplier shall provide material specifications and shop drawings.
- D. The 2004 Hankin "Modification to Fluidized Bed Incinerator" drawings are attached at the end of this section.
- E. The materials provided as part of this Agreement will be installed by a Contractor under a separate contract.

SUBMITTALS

A. The materials supplier shall furnish to the DISTRICT for review an electronic PDF version of the materials submittal to demonstrate compliance with these specifications. The term

"submittal" as used herein shall be understood to include installation drawings, catalog sheets and data sheets. Submittals shall be made within the time limits identified in the Bid Form.

- B. Submittals shall include at least the following:
 - 1. Descriptive literature, bulletins, and/or catalogs of the materials, materials and details of construction, indicating full compliance with this Section.
 - 2. Provide design data, test reports, and warranty data.
 - 3. A complete total bill of materials for all equipment.
 - 4. Manufacturer's instructions for delivery, unloading, storage, handling and installation of the materials.

QUALITY ASSURANCE

A. Qualifications - The materials specified under this Section shall be furnished by a manufacturer who is fully experienced, reputable, and qualified in the manufacture of the materials furnished.

EXECUTION

- A. Supplier shall be responsible for shipment and delivery of the materials to the DISTRICT's facility in Asheville, North Carolina. Offloading and installation will be by others. Deliver the materials suitably protected for storage at the DISTRICT's facility prior to installation. Installation of said materials is scheduled for Winter/Spring 2026.
- B. All materials shall be factory tested for compliance with the construction and functional requirements specified herein, and a certification of the results of these tests shall be submitted to the ENGINEER.
- C. The Contractor will verify proper operation of the materials during startup of the the existing fluidized bed incinerator. The materials shall demonstrate compliance with the operating requirements specified herein. Any deficiencies in the operation of the materials, due to the design or manufacturing, shall be repaired or corrected by the supplier at no additional cost to the DISTRICT.
